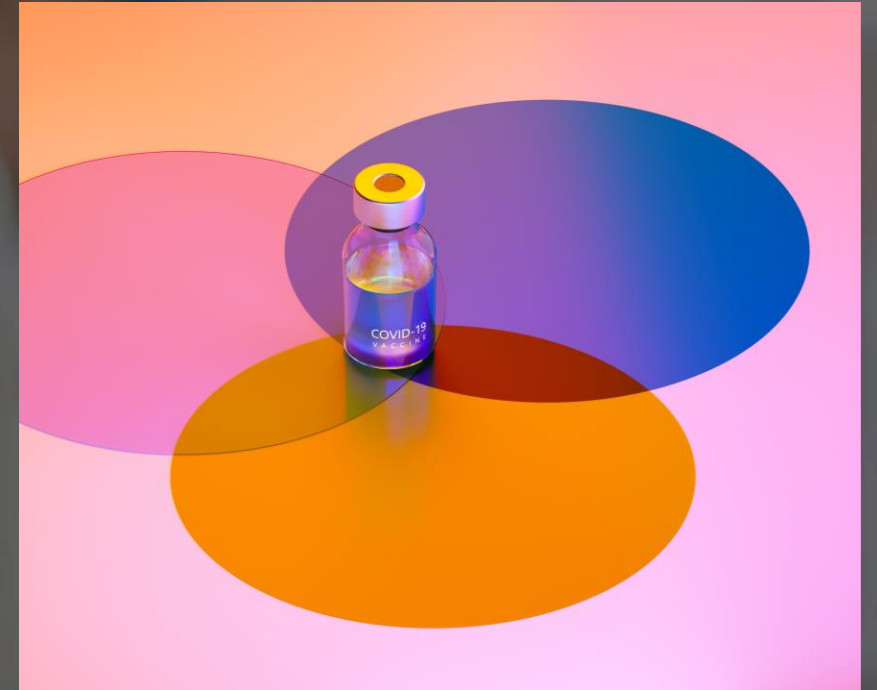


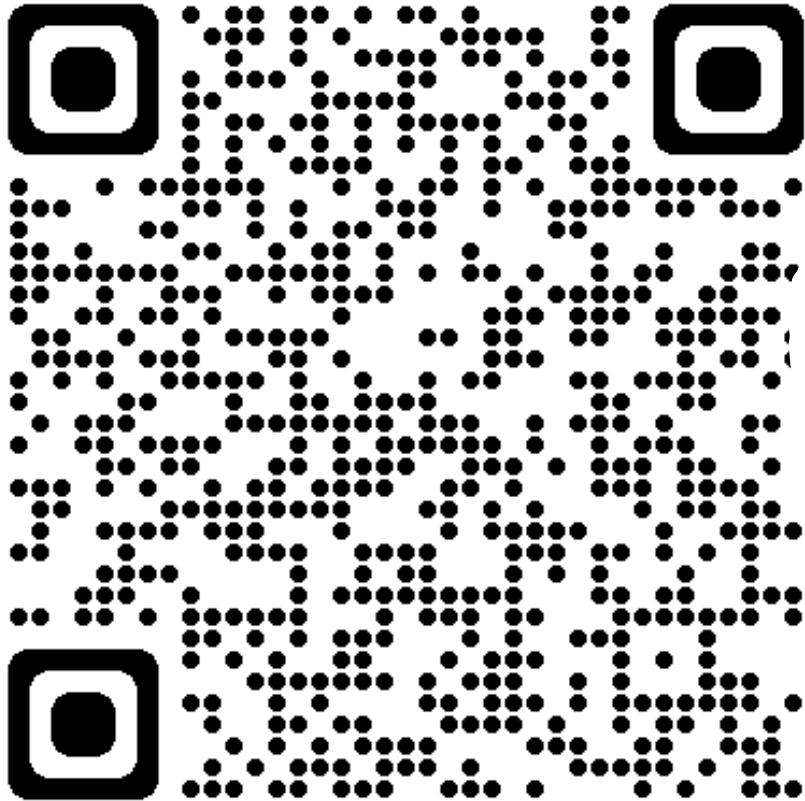

Immunization requirements

- ▶ No student shall be admitted by a school unless at the time of admission the student or his/her guardian submits documentary proof of immunization on the [Commonwealth of Virginia School Entrance Health Form](#) to the admitting official of the school or unless the student is exempted from immunization for medical or religious reasons, the student is a homeless child or youth or the student is in foster care. [See Regulation 723-6, Immunization Requirements](#) for additional information.





Required Immunizations

Hepatitis B

- 3 Doses

DTap/Td/DT

- 5 Doses (Last Dose 4-6 Yrs. Old)

MMR

- 2 Doses

Polio

- 4 Doses (Last Dose 4-6 Yrs. Old)

Varicella (Chicken Pox)

- 2 Doses OR Proof of Disease

Hep A

- 2 Doses (will not show non-compliant in middle school)

▶Children may be vaccinated at the Manassas or Woodbridge clinics of the Prince William County Health Department or through other medical professionals. Vaccinations that are required for entrance into school are free at county health clinics. Please call the health clinic for times and schedules prior to visiting.



Reasons to stay home or get sent home

- ▶ Fever of 100.4° F and over - exclude until student has been fever-free **without the use of fever reducing medications (Tylenol, Motrin, etc.)** for at least 24 hours.
- ▶ Conjunctivitis (pink eye), strep, ringworm, and impetigo are all infections and must be treated with medication for a minimum of 24 hours before returning to school to avoid infecting other children.
- ▶ Rash of unknown origin with fever and/or behavioral changes, until a primary care provider has determined that the illness is not a communicable disease.
- ▶ Head injury.
- ▶ Severe coughing or difficulty breathing.
- ▶ Colds - a child with thick or constant nasal discharge should remain home.
- ▶ Diarrhea - sudden increase in frequency to more than three loose/watery stools per day. Exclude until student has been symptom free for at least 24 hours.
- ▶ Vomiting - unless the vomiting is determined to be caused by a diagnosed non-communicable/non-infectious condition (such as dysmenorrhea, dysphagia, etc.).
- ▶ Abdominal pain that continues for more than two hours or intermittent abdominal pain associated with fever or other signs or symptoms.
- ▶ Stiff neck associated with fever and/or a recent injury.
- ▶ Inadequate immunizations with known disease outbreak in school.
- ▶ Refer to the Virginia Department of Health's "Communicable Disease Reference Chart for School Personnel" for other exclusions/information.

Medication At School

Medications should be taken at home whenever possible

- ▶ If it is absolutely necessary for the student to take medication at school, the Authorization for Medication Administration form must be received for each medication and must be submitted to the health office staff prior to the medication being given at school.
- ▶ Prescription medications - Medications (including physician/pharmacy samples) must be in the original pharmacy bottle with proper label containing:
 - ▶ Student's name;
 - ▶ Name of medication;
 - ▶ Time to be given;
 - ▶ Dose/amount to be given; and
 - ▶ Name of health care provider.
- ▶ Non-prescription medications (over-the-counter) must be in the original sealed package with the name of the medicine, instructions, and must not have exceeded the expiration date. Non-prescription medication will only be administered according to directions on the label. If a higher/lower dosage is required, the Authorization for Medication Administration form must be signed by the health care provider.

Otherwise, students are not permitted to transport medications to and from school or carry any medication while in school
